

# T-Signature Data Privacy Policy

## PRIVACY POLICY

T-Signature is committed to protecting your privacy. This Statement of Privacy applies to the T-Signature, services, and governs data collection and usage. By using the T-Signature App and services, you consent to the data practices described in this statement.

## Collection of Personal Information

T-Signature may collect personally identifiable information, such as your name, telephone number. T-Signature doesn't collect any personal information of customers.

## Use of Personal Information

T-Signature collects and uses your personal information to operate the T-Signature App and deliver the services you have requested. T-Signature may also use your personally identifiable information to inform you of other products or services available from T-Signature and its affiliates. T-Signature may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

T-Signature does not sell, rent or lease its customer lists to third parties. T-Signature may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (name, telephone number) is not transferred to the third party. In addition, T-Signature may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to T-Signature, and they are required to maintain the confidentiality of your information.

T-Signature will never disclose any personal data without explicit permission from the customer, except, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on T-Signature or the site; (b) protect and defend the rights or property of T-Signature; and, (c) act under exigent circumstances to protect the personal safety of users of T-Signature or the public.

T-Signature does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

T-Signature keeps track of the Websites and pages our customers visit within T-Signature, in order to maintain recently used pages or reports and to offer such customized services to its Users.

## Security of Personal Information

T-Signature secures your personal information from unauthorized access, use or disclosure. T-Signature secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a social security number or other personally identifiable information) is transmitted to other Websites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.
